- 1. That Shri Guru Ram Rai Education Mission, Managing Committee, Dehradun is a registered Society/Trust under the Society Registration Act 323/1952-1953 dated 16.03.1956.
- 2. That the Shri Guru Ram Rai Education Mission, Managing Committee is of Non-Proprietary Character.
- 3. That no member of the School Management Committee is related to each other by blood relation.
- 4. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.
- 5. That no part of income from the institution shall be diverted to any individual in the Trust/Society/Company registered under section 25 of the companies act, 1956 School Management Committee or to any other person. The savings, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation and contingency funds may be further utilized for promoting the school land extending the cause of education in the same school only.
- 6. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body organization.
- 7. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 8. That the principal and Corresponding/Manager of the school have individually gone through the provisions contained in the affiliation & examination bye-laws and the circulars issued by the board from time to time. The School undertakes to abide by the provisions contained in the affiliation & examination bye-laws, directions issued from time to time and the law of the land.
- 9. That the school will ensure compliance of all statutory requirements like, EPF, ESI and Labourd aws etc. with respect to the school and staff of the school.
- 10. That the school will ensure that the Building safety, Fire safety, water safety, Health & Hygrene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
