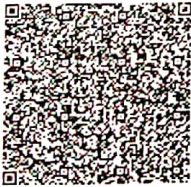

1. That Shri Guru Ram Rai Education Mission, Managing Committee, Dehradun is a registered Society/Trust under the Society Registration Act 323/1952-1953 dated 16.03.1956.
2. That the Shri Guru Ram Rai Education Mission, Managing Committee is of Non-Proprietary Character.
3. That no member of the School Management Committee is related to each other by blood relation.
4. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.
5. That no part of income from the institution shall be diverted to any individual in the Trust/Society/Company registered under section 25 of the companies act, 1956 School Management Committee or to any other person. The savings, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation and contingency funds may be further utilized for promoting the school land extending the cause of education in the same school only.
6. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body organization.
7. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
8. That the principal and Corresponding/Manager of the school have individually gone through the provisions contained in the affiliation & examination bye-laws and the circulars issued by the board from time to time. The School undertakes to abide by the provisions contained in the affiliation & examination bye-laws, directions issued from time to time and the law of the land.
9. That the school will ensure compliance of all statutory requirements like, EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
10. That the school will ensure that the Building safety, Fire safety, water safety, Health & Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.

12. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.

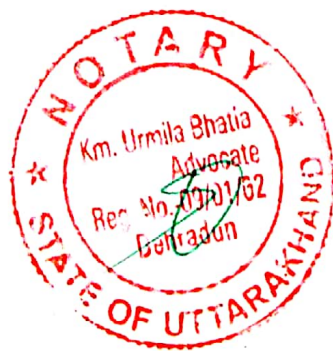

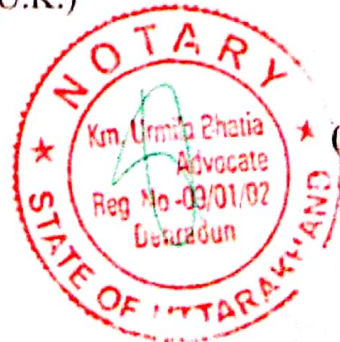

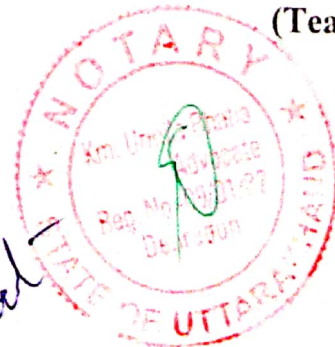
